IMPORTANT DATES & SUPPLEMENTARY EXAMINATION JULY 2020

In continuation to the notification vide ref number IUS/GTK/RG/052, dated 12th June 2020, the following notification is divided into two sections:

SECTION-A (IMPORTANT DATES)

1. The students need to submit the soft copy of the IT Project/Project/Management Thesis papers to their respective guides on or before 10th July 2020. However, the students should be ready with the hard copy as the University may ask to courier or physically submit the same, if required.
2. For Clinical Law II (Moot Court), the Viva Voice and all the formalities should be completed by 5th July 2020.
3. Final year students who have not submitted the passport size photographs for processing their Grade Sheets, Degree & Transcripts are hereby informed to scan in .jpeg format and email the same at pemacbhutia@iusikkim.edu.in on or before **30th June 2020** failing which their certificates will not be processed.

SECTION-B (SUPPLEMENTARY EXAMINATION)

Guidelines for appearing in Supplementary Examination July 2020

1. Eligible students name are mentioned in Annexure-I to appear for the Supplementary Examination July 2020.
2. The students who are appearing for supplementary examinations should log in with their enrolment number in the University website to download the assignment(s) on or after **7th July 2020 till 10th July 2020**.
3. The hand written assignments should be properly scanned in **(.pdf format)** and mailed to the Examination Department only and on or before **10th July 2020**, latest by **4 pm**. Please mention your name, enrolment number, semester, subject title & program. Assignment(s) sent after the stipulated date and time will not be entertained.
4. The University further shall not entertain any request for writing supplementary examination.

5. For any reason, if a student fails to submit the assignment(s) as per the guidelines mentioned above, he/she shall be guided in accordance with the Examination Rules & Regulations.
6. For record purpose, the students should preserve the hard copy of the hand written assignments for a minimum period of 4 months. The University may ask to courier/scan etc or physically submit the same, if required.
